## **MEAL PLAN CONTRACT**

CHAPTER COMMONS DINING, NC STATE UNIVERSITY

- I. **Contract Period:** The meal plan contract provides meals for the fall and spring semesters. Meals are not provided during some holidays and break periods.
- II. Eligibility: All student members of the Fraternity and Sorority Life community without a chapter provided meal plan are eligible to enroll in the Chapter Commons Dining meal plan. However, this meal plan is required for first-year students in order to qualify for transfer from University Housing to Greek Village for spring semester if their chapter does not have a qualifying meal plan in their facility. (See Item IX for exceptions.) The meal plan contract is for an academic year, billable by semester. Visit fsl.dasa.ncsu.edu for details and instructions.
- III. Acceptance: The student accepts the terms and conditions of this contract upon completion of the enrollment form.
- IV. Meal Plan:
  - A. The Chapter Commons Dining meal plan offers breakfast, lunch and dinner, Monday Friday while classes are in session. For fall semester, non resident meals start on the Monday after formal recruitment.
    - 1. First-year students who join a chapter residing in Chapter Commons in the fall semester through formal recruitment can opt into the meal plan on the Monday after formal recruitment. The rate for new members represents a prorated reduction in cost.
    - 2. First-year students who transfer to Greek Village over winter break must be on the Chapter Commons Dining meal plan if their chapter does not provide a qualifying meal plan in order to qualify for the transfer from University Housing. Spring meal plans run while classes are in session.
    - 3. First year students may elect to reduce their required University Dining meal plan when joining a qualifying meal plan in Greek VIIIage. Changes should be made by Sept. 1, 2025, in the fall and Jan. 26, 2026, in the spring to avoid a late fee. For information on accommodations for first year students who join a meal plan in Greek VIIIage, visit dining.ncsu.edu.
  - B. Meal plan cancellations for the fall semester must be completed by Sept. 22, 2025. Students will be automatically enrolled in the same meal plan for the spring semester unless we are notified otherwise by October 10, 2025. Meal plan cancellations for the spring semester must be completed by Feb. 16, 2026. These changes can be made using the online cancellation form on fsl.dasa.ncsu.edu.
- V. Dining Payment: Meal plans are billed by semester through the University Cashier's office. Payment is due in accordance with the deadlines established by the University Cashier's office. Failure to make payment when due may result in penalties, including a block on registration and/or transcripts. The rate for the 2025-2026 meal plan is \$2,080 per semester. Fall non residents and new members, and spring new member plans are reduced to \$1,690 to account for the 3 week delay in start. Spring delay is only for those students who join an organization in the spring semester.
- VI. **Contract Termination by the University**: Upon reasonable notice and for good cause, the university reserves the right to terminate this agreement for the failure of the student to abide thereby. Examples of good cause are a change in student status (including academic or disciplinary suspension) and failure to comply with the policies and regulations posted on the Fraternity and Sorority Life website, electronic communication, and information bulletins, which are hereby made a part of this agreement.

## VII. Contract Termination by the Student:

- A. Failure to participate in the meal plan does not automatically release a student from their dining contract.
- B. First-year students housed on campus may terminate this agreement for one of the following reasons:
  - 1. Moving back to University Housing and rejoining the University Dining meal plan.
  - 2. Withdrawal from NC State.
  - 3. Participation in an approved program or academic project that provides and/or requires meals off campus.
  - 4. Medical condition with dietary requirements that cannot be met by the services of Chapter Commons Dining.
- C. Any student not required to be on the meal plan may cancel for any reason by Sept. 22, 2025, for the fall semester and Jan. 26, 2026, for the spring semester by visiting fsl.ncsu.edu and completing the cancellation request.
- VIII. **Refunds and Termination Charges:** Contracts canceled after the start of classes will result in a refund of advance payment minus a prorated, daily rate. Contracts canceled after Sept. 1, 2025, for the fall semester and Jan. 26, 2026, for the spring semester will result in a refund of advance payment as noted above minus a \$250 cancellation fee.
- IX. **DISCLAIMER:** NC State reserves the right to close campus dining locations and/or adjust the hours of operation as necessary in NC State's sole discretion as business conditions require and/or to preserve the health and safety of students and the campus community.
